1. Approval of the 2025 Proposed Millage Rates (Form L-4029), Proposed Resolution 2025-29.

Allocated operating millage is 0.9531 and voted fire millage is 3.4786 expiring December 31, 2027.

Resolution to Approve the 2025 Tax Rate Request (Form L-4029)

**WHEREAS,** the Michigan Department of Treasury requires completion and submission of Form 614 (Rev. 2-25), also known as L-4029, the 2025 Tax Rate Request, pursuant to MCL Sections 211.24e, 211.34, and 211.34d; and

WHEREAS, Rose Township is required to certify its 2025 tax rates to the Oakland County Equalization Department and to the Rose Township Clerk no later than September 30, 2025; and WHEREAS, the following millages have been authorized and are available for levy on the 2025 tax roll:

- Allocated Operating Millage: Maximum allowable levy of 0.9531 mills.
- Voted Fire Millage (approved August 2, 2022, expiring December 31, 2027): Maximum allowable levy of 3.4786 mills; and

**WHEREAS,** the Township Board finds it necessary and proper to approve the completion and submission of Form L-4029 to ensure compliance with State law and to authorize the levy of the certified tax rates.

**NOW, THEREFORE, BE IT RESOLVED** that the Rose Township Board hereby approves the Michigan Department of Treasury Form 614 (L-4029) – 2025 Tax Rate Request as presented. **BE IT FURTHER RESOLVED** that the Township Supervisor and Township Clerk are authorized and directed to sign and submit the completed form to the Oakland County Equalization Department and to the Rose Township Clerk, as required by law.

Motion by Treasurer Jobes to approve the Michigan Department of Treasury Form 614, the 2025 tax rate for Rose Township as presented and to authorize the Township Supervisor and Clerk to sign and submit the form to the Oakland County Equalization Department and Rose Township Clerk in compliance with state law. Supported by Trustee Maher. A roll call vote was taken. The motion was carried 5/0.

The Holly Township Library has submitted invoice #1001, dated August 5, 2025 in the amount of \$12, 892.00 representing the per capita library services contribution of the 2025/2026 fiscal years based on the Township's population if 6,446.

Resolution to Approve the Holly Township Library Services Contract and Payment

WHEREAS, the Township of Rose entered into an agreement on July 2, 2024, with the Holly Township Library for the provision of library services to Rose Township residents; and WHEREAS, the agreement provides that Rose Township shall annually budget \$2.00 per capita for library purposes in addition to assigning 100% of penal fines allocated to the Township under Public Act 59 of 1964; and

**WHEREAS,** the Holly Township Library has submitted Invoice #1001, dated August 5, 2025, in the amount of **\$12,892.00**, representing the per capita library services contribution for the 2025/2026 fiscal year based on the Township's population of 6,446; and

**WHEREAS,** the Township Board has determined it is in the best interest of Rose Township residents to continue participation in this library services agreement.

**NOW, THEREFORE, BE IT RESOLVED** that the Rose Township Board hereby approves payment of Invoice #1001 in the amount of **\$12,892.00** to the Holly Township Library for 2025/2026 library services

**BE IT FURTHER RESOLVED** that the Township Treasurer is authorized and directed to issue payment in accordance with the approved agreement.

Motion by Trustee Bourdeau to approve the Holly Township library service contract and payment, Proposed Resolution 2025-30, in the account of \$12,892.00 for the 2025-26 library services and to authorize the Township Treasurer to issue payment as budgeted.
