TO THE QUALIFIED ELECTORS OF ROSE TOWNSHIP:

PLEASE TAKE NOTICE that any qualified elector of Rose Township who is not already registered, may register to vote at the office of the Township Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at mi.gov/vote and mailed to the Township Clerk. Voters who are already registered may update their registration at Michigan.gov/Vote.

The last day to register in any manner other than in-person with the local clerk is **Monday, October 21, 2024**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at the Rose Township Clerk's office, located at 9080 Mason St., Holly, MI 48442 at the following times:

- Regular business hours: Monday – Thursday from 8:30 a.m. to 4:30 p.m.
- Saturday, November 2, 2024 8:30 a.m. – 4:30 p.m.
- Election Day, Tuesday November 5, 2024, from 7:00 a.m. to 8:00 p.m.

Proposal Section - Oakland County Parks and Recreation Millage - To continue to provide revenue to the Oakland County Parks and Recreation Commission, shall the current millage, which has been reduced by required rollback, be replaced, and increased to .65 mills for 20 years from 2024 to 2043, The .65 mills is equal to 65 cents per \$1,000.00 of taxable value. The millage, if approved and levied, shall generate approximately \$52,191,139 in 2024.
