NOTICE IS HEREBY GIVEN, that the Rose Township Board of Trustees will hold a public hearing on Wednesday, October 27, 2021 at 6:00 PM in the Rose Township Offices, 9080 Mason Street, Holly, Michigan.

THE PURPOSE OF THE HEARING is to hear objections to a petition submitted to the Rose Township Board of Trustees for the creation of a special assessment district for maintenance of the private road known as Williams Drive. The petition has been determined to be sufficient (contains the signatures of property owners representing greater than 50% of the road frontage on Williams Drive). The proposed special assessment district includes all properties having an ownership interest in Ottieway Court. The *estimated* cost of performing the requested road maintenance is \$190.00 per property plus a 3% administration fee and township costs associated for the first year and subsequent years. 
