While I am not a Rose Township resident (yet) I appreciate the work you put in on behalf of the residents. I know your focus is to make the township the best it can be for the residents you serve. I do spend a lot of time in your township, and I drive an hour and half one way to do so.

I volunteer at The Devoted Barn Sanctuary. I have a unique perspective to offer on the current issues. I have been volunteering with The Barn for 9 years. In that time my role has changed. I now oversee and give tours to individuals and groups, I organize some of the community events and outreach, and I foster.

Since we have moved to the area, I have been lucky enough to meet many amazing Rose Township residents when they have come out for a tour. They are always very positive about us being in the area. Many return with donations, to volunteer, or to visit again. As I am sure you are aware, the property was in very rough shape when The Devoted Barn bought it. One of the first comments I receive is "Wow the property looks so much better, it is no longer an eye sore". In this pandemic it is a struggle to find things for a family to do, and visiting the barn has been a breath of fresh air for many residents. Many nonresidents have also come for tours. When they come, they help stimulate the local economy. Many drive far so they patronize food establishments, gas stations, and several stay in area hotels or at campgrounds overnight in season.

I work with a number of groups. In the past few years we have hosted several Boy and Girl Scout troops, group homes and nursing homes, groups that serve veterans, a school for vet techs, a school for at risk youth, and even teamed up with the Holly Library for read to an animal day. Several of the Boy and Girl Scout troops have returned and earned a variety of badges at The Barn. Again this includes several residents of Rose Township and several people who drove a distance to get to The Barn. Many ask for information on local attractions, lodging, and food establishments.

The Devoted Barn works closely with several animal controls. Often we are stepping up to help with cases of hoarding, neglect, abuse, and catching stray animals when no one else can or does. We also work closely with other rescues, the Department of Agriculture, and several police departments. The Devoted Barn is often visited by The Department of Agriculture and Animal Controls when they come to check on animals that are evidence in current criminal investigations. If you check you will find The Devoted Barn to be in good standing with all of these entities. I know you must take the source into consideration when making decisions on the validity of claims. Thank you for doing your due diligence and seeking the input of professionals in the appropriate fields.

I welcome you to come and volunteer a few times with our volunteers. You will see a team of dedicated people and some very spoiled and loved animals. It would be a great way to see first hand the work done every single day to ensure all animals have their needs met. I tell my son and my students to do good every day, but most importantly not cause harm to others. Through my volunteering with The Devoted Barn I have been able to teach compassion and live out that saying with countless children. The impact The Barn has on youth is magical to experience.

Rose Township is lucky to have this gem in their community. It is a benefit to the residents and animals alike. I trust you will see this as the positive place it is and how it benefits your community.

Dear Township Members,

Like all small towns, word travels fast. It has been brought to my attention that TDB now has a new campaign to have volunteers and followers write to you stating that it is a death sentence for the dogs, if they are forced to be moved off of the property. First of all, where is the worst place they might go? A foster who will work one on one with them, another dog rescue who knows how to work with scared dogs or Animal Control. Even being put in Animal Control, the dogs would be in a facility that has controlled temperatures. No more subzero temperature days and nights in the winter with their water frozen so that the volunteers have to take a mallet to break the ice numerous times so they can have water. No more summer days of 90+ temperatures with smells of urine turning into ammonia that is unbearable, not to mention the hundreds of flies. To have 24/7 access to clean drinking water not slimy water from the well. To have dedicated volunteers still willing to love on them and even have MORE time to put real training into them to advance them into loving homes. Where they will receive needed medical care and supplies without waiting for needed donations to come in first. When Miss Borden was told the dogs would have to move this past summer, numerous volunteers looked into renting other facilities but that was shot down by Miss Borden. She didn't want to try and raise the money. But, she could rescue more medical needs horses and livestock which will cost many thousands of dollars for veterinary care. If Miss Borden truly cared about these dogs she would have been pushing to get them into foster homes not getting more puppies and having them go into foster homes.

I have included multiple examples from TDB's own FB page of FERAL and unleash trained barn dogs safely being put into homes. Not to mention Blackie, Poppy, Gilly, and the list goes on. Many of TDB dogs have been found out to be house trained when put into a home. Please educate yourself on their new false claims that it is a death sentence for the dogs. Most rescues would find it embarrassing that within 3 days the dog that sat for YEARS in your barn was leash trained and living in a house with a new pack and was thriving! In fact within months that "untrainable" barn dog was trained and in his permanent home. That dogs name is Micah and his story and also be found on FB. Micah is like the 3rd dog this man has saved from TDB.

A local rescue, Adopt A Pet of Fenton, took in about 60+ feral dogs. Those animals were properly cared for considering their horrific situation they were removed from. They were found to be stable and safe to be placed in the correct permanent homes within probably 4-6 months. Again this just goes to show that if Ms. Borden really wants her volunteers and followers to inundate the Township with threats that is a death sentence for the dogs, well it says more about her rescue or lack of rescue. You can't show the public how you can place a feral, non-leash trained animal to live in a home and say it is a death sentence for the to leave the Barn.







My family and I originally lived on Fish Lake and Rose Center. We moved into our new home on Rattalee in June. I share this because I am heavily invested in this area. I now have my forever home and it in In Rose Twp. Because of this, it is my responsibility to speak and share my experience with The Devoted Barn.

My husband once worked at the farm, which is now The Devoted Barn, decades ago as a kid, our daughter began talking lessons there when it was still owned by Huntington Ridge. We leased horses and eventually came to the decision to buy one. While our horse was under the care of Hunting Ridge, we were told that she needed to be kept in a pasture, alone and that she didn't get along with other horses. The small pasture she was put in, also didn't have any shelter for her to go to- even during the winter! I was told she didn't need it.

About this time Melissa Borden bought the property. Melissa was very involved from the beginning. She took the time to meet the people that participated in the Huntington Ridge schooling program, which she allowed to continue when she didn't have to. She and her volunteers began cleaning up the property and made it inviting to anyone that visited. We were all invited to meet the animals- the volunteers are wonderful! They would happily share with you what they were doing, perhaps what dog they were walking and the history of the animal. Watching what was going on, it made me want to be involved and learn more. The change was positive

Melissa had approached me and asked about the situation with my horse, Loretta, is her name. She shared her concern, in regards to her being outside with no shelter. She offered to have Loretta in one of her pastures, with other horses, and shelter. Shortly after the Covid shutdown, that is what happened. Wouldn't you know it, Loretta has happily been with multiple other horses since. Melissa Borden worked with my horse, to make her as happy and comfortable as possible. Loretta went from solitary confinement and no shelter with Huntington Ridge to having someone truly care and she has a completely different personality with the Devoted Barn. What a difference when someone who truly loves animals is involved. I am beyond grateful

Most of my experience with the devoted barn are with the horses, but I must say that every aspect of the organization is top notch- it must be since she is also the person that Oakland county trusts and gives their criminal cases to. That is correct- literally- the higher ups trust her and her rescue and rehabilitation program over anyone else in Oakland county-who of course is under the watchful eye of the state of Michigan. It is safe to say that she is visited often and the farm and its operations are monitored for quality.

There always be people that will talk, spread rumors or make ignorant accusations. It is so disappointing. I am certain that a group of intelligent and educated people would not allow

themselves to be pulled to such a low level. Melissa Borden is one of the most dedicated and hardworking people that I have ever had the pleasure of knowing.

I whole heartly support the Devoted Barn in Rose Twp. From the positive events, allowing families to enjoy the simple experience of spending an afternoon together in our community to the dog program which saves animals from hording cases, abuse where dogs have literally froze to the ground, sexual abuse- it goes on. Dear Board Members

I am writing to you today in support of The Devoted Barn. First, a little background. My husband and I moved to Rose Township in December of 2019. Our house and property are what we dreamed of having, and we are so happy to be able to live here. After Covid hit, my job went remote. Shortly after that we experienced some painful personal losses. To say I was struggling emotionally would be an understatement. That's when I found The Devoted Barn. I went for a tour in September of 2020 and began volunteering in the dog room in October. I have been there nearly every Wednesday evening and Saturday morning since.

What working with the dogs at The Devoted Barn has given me can't be quantified, or put into words. I love these dogs. They come from places where they have been abused and neglected and have never experienced love. Yet they learn to trust and give love in return. Since I started I have witnessed so many wonderful moments. When a dog allows touch for the first time. Or a dog, too scared to come out of it's kennel when humans are around, decides to explore and take treats at play time. These aren't isolated incidents. They are happening all of the time. And it's because of 2 things. One, dogs are resilient and amazing in their capacity to forgive and trust. And two, the barn family is full of volunteers who give of themselves fully to help rehabilitate these animals.

There is a quote attributed to Mark Twain that says "The more I learn about people, the more I like my dog". I can identify with this quote. I am someone who generally prefers the company of animals to that of people. Therefore please understand that my loyalty is to the animals. If I felt that they were being abused or neglected in any way I would not stand idly by. I cannot stress that point enough. I spend over 10 hours a week in the dog room. I have first-hand knowledge of what happens there. I am invested in these animals. And I believe with my entire being that this is the

best place for them. And while I may not be a fan of people, I have come to love and respect the people in this barn family. Their devotion and compassion as a community of volunteers is something I have never witnessed before.

These dogs are the hard cases. The ones that are completely shut down and labeled as unadoptable at shelters. But they are no less worthy of our love or time. They deserve a chance. And a place where they are shown love and compassion. And for many of these dogs, all the patience and love pays off and we get to see them go to their forever home. For the others, we will keep working tirelessly and meet them where they are. And provide for their needs the rest of their life if need be, I am proud as a Rose Twp resident to have The Devoted Barn here in our community. Because it shows that we as a community value things like empathy and kindness and second chances.

Finally, I do not envy your position here. I give you credit to be called to be a public servant. I imagine on some (maybe most) days it can be a pretty thankless job. It kills me that my tax dollars are going to fight this sanctuary that I love, and that has given me so much. Dear Board Members

I am writing to you today in support of The Devoted Barn. First, a little background. My husband and I moved to Rose Township in December of 2019. Our house and property are what we dreamed of having, and we are so happy to be able to live here. After Covid hit, my job went remote. Shortly after that we experienced some painful personal losses. To say I was struggling emotionally would be an understatement. That's when I found The Devoted Barn. I went for a tour in September of 2020 and began volunteering in the dog room in October. I have been there nearly every Wednesday evening and Saturday morning since.

What working with the dogs at The Devoted Barn has given me can't be quantified, or put into words. I love these dogs. They come from places where they have been abused and neglected and have never experienced love. Yet they learn to trust and give love in return. Since I started I have witnessed so many wonderful moments. When a dog allows touch for the first time. Or a dog, too scared to come out of it's kennel when humans are around, decides to explore and take treats at play time. These aren't isolated incidents. They are happening all of the time. And it's because of 2 things. One, dogs are resilient and amazing in their capacity to forgive and trust. And two, the barn family is full of volunteers who give of themselves fully to help rehabilitate these animals.

There is a quote attributed to Mark Twain that says "The more I learn about people, the more I like my dog". I can identify with this quote. I am someone who generally prefers the company of animals to that of people. Therefore please understand that my loyalty is to the animals. If I felt that they were being abused or neglected in any way I would not stand idly by. I cannot stress that point enough. I spend over 10 hours a week in the dog room. I have first-hand knowledge of what happens there. I am invested in these animals. And I believe with my entire being that this is the best place for them. And while I may not be a fan of people, I have come to love and respect the people in this barn family. Their devotion and compassion as a community of volunteers is something I have never witnessed before.

These dogs are the hard cases. The ones that are completely shut down and labeled as unadoptable at shelters. But they are no less worthy of our love or time. They deserve a chance. And a place where they are shown love and compassion. And for many of these dogs, all the patience and love pays off and we get to see them go to their forever home. For the others, we will keep working tirelessly and meet them where they are. And provide for their needs the rest of their life if need be, I am proud as a Rose Twp resident to have The Devoted Barn here in our community. Because it shows that we as a community value things like empathy and kindness and second chances.

Finally, I do not envy your position here. I give you credit to be called to be a public servant. I imagine on some (maybe most) days it can be a pretty thankless job. My hope is that you will see that the value of coming to an agreement with The Barn far outweighs the costs of continuing this fight. It kills me that my tax dollars are going to fight this sanctuary that I love, and that has given me so much. So as those that have the task to stand up for the citizens of this community, I felt you should know that as a resident, I stand with The Devoted Barn.





These are just a few of the many success stories that we have had this past year.




King is a dog who came to us from a hoarding case in Oklahoma where 87 dogs were rescued from a single wide mobile home. I remember seeing pictures of King and the dogs from the hoarding case he came from; it broke my heart. They all were so fearful. King wasn't exactly friendly at first but now with all the patience and work of the barn volunteers at the sanctuary he has come to be one of the friendliest dogs. He loves to give kisses, get pets, join roll call and play with his friends. He is now in his forever home. He has learned about all kinds of new things like backyards and pup cups and doggie cookies and car rides and making snow angels which is one of his favorites.



Blackie came to The Devoted Barn from Toledo. He spent many years with is elderly owner who would take him for daily walks through the neighborhood. They were very bonded. Unfortunately, when his owner passed away, the gentleman's family did not want to keep Blackie so he was left behind in the neighborhood. Blackie continued to make his daily walks throughout the neighborhood for years. The neighbors fed and cared for him. He would spend time watching the neighbor garden, just like he did with his prior owner. He is quite loyal and was protective of the

kids in the neighborhood. When new people moved into Blackie's prior home, they started chasing him off. That's when a rescue contacted The Devoted Barn who went and brought him back to the barn. Blackie is approximately 10 years old and this past year he has found his forever home and is doing wonderful.




Dazzle came to us from Thailand in July of 2017 via the Soi Dog Foundation. We don't know how old she is, but believe she is between 5 and 7 years old. She was very fearful and shut down in Thailand. We can only imagine the trauma she went thru while she was in the meat trade. Our volunteers worked with her with patience, love and enrichment tools. Dazzle started to show us that she was beginning to trust our volunteers and wants to interact with all of us. Dazzle went to a foster home to learn how to live in a home and has just recently moved on to her forever home.



Thai He is doing well with his foster mom and fur sister. He is a stubborn old man and is making slow progress on potty training. It's done on his terms lol. He loves to greet people at the door but won't hesitate to bark at you if you don't belong. He is spoiled with all the treats and has run of the house but enjoys snuggling up on his bed.



Dora is around 12 years old. She came to the barn from the SOI Dog Foundation in Thailand in November of 2017. Her Soi dog records show craniodorsal right hip luxation (usually caused by traumatic injury). The vet here in Union lake mentioned that seems to match up with a lot of what I see in Dora is degenerative myelopathy. Dora has been adopted by her foster mom. Dora's most favorite activity is long walks with her rear-lift harness. Her disability doesn't slow her down one bit. She only accepts the highest quality of food and treats. She has the most precious snore when she's sleeping.



Dree came to The Devoted Barn all the way from Thailand where she was rescued from the former dog meat trade. When Dree arrived she was a shyd dog who was very fearful at first, but that's understandable considering where she came from and what she had been through in her life before her rescue. After some time at the Devoted Barn where the volunteers gained her trust, showed her that all humans were not terrible she came our of her shell and was ready for her forever home. She found her ideal home with her adoptive mom where it was quiet, peaceful, and relaxed. Although she is a senior dog she loves long walks, petting, chewies, treats, cuddly beds and toys.



Good afternoon Board Members,

I am a resident of Holly and am a volunteer at The Devoted Barn. I spoke up at the last board meeting in support of The Devoted Barn. I know you are getting a lot of emails from fellow supporters and the reason is simple; it is an amazing place.

In my speech at the last meeting, I encouraged you all to come and visit us at the barn and I am wondering if any members were able to?

I have been a volunteer for about a year and half and I work with the dogs. I can assure you of a few things. These dogs are happy and they are taken care of. They receive more routine veterinarian care than most animals that I have seen who have homes. If a dog is acting like something is bothering them, they are looked at by our licensed vet ASAP. They are given medication should they need it. That is better care than some dogs who have owners and its certainly care they never received before The Devoted Barn.

These dogs eat very well. We have many volunteers who bring in rotisserie chickens, even roasts, to give the dogs a treat. They eat better than my own dog! Heck, they eat better than me! They are given plenty of food. If they are picky, we get them the food that they like. They eat twice a day and always have access to a bucket of water that is changed for freshness twice a day.

To expand on my earlier statement that these dogs are happy, I can assure you they receive love that they have never known until they arrived at the barn. I am literally unable to be at the barn without cuddling with Nyla. She loved cuddles more than any dog I have ever seen and that is why myself, and so many others, love letting her climb onto our laps and just hold her. I cannot see Oakley without giving her a belly rub that she

insists on. I cannot see Charity and not (forgive me for being so blunt) give her the butt scratches that she loves so much. I cannot look away from Duffy's kennel as she rearranges her furniture because she is so funny doing it! I am always amazed at Copper for, despite a birth defect, being able to zip around the barn at lightning speed. Each dog has their own sense of humor. They truly are a delight to spend time with. Seeing them come out for play time and chase each other and their favorite toys is our favorite thing to witness as volunteers. It's so important because before their life at The Devoted Barn, most were strays or meat trade dogs. They did not know how to play. If you are not someone who has spent time with dogs that come from backgrounds like that, it's hard to imagine a dog not being able to play but it is true. It is not until they come to the barn that they feel safe and happy enough to BE A DOG!

In the winter months, the dogs are given igloos that are filled with straw. In addition to that, we receive blanket donations from all of our supporters and they are given blankets that they love cuddling up in. I personally have dropped off blanket donations. They do NOT have to sit on dirt floors.

You have gotten so many letters from supporters because they know first hand how much we, as volunteers, love these dogs. What we are asking for is simple, we want to come to an agreement where all parties are happy. That IS a possible outcome. I know that Melissa has explained what she would be able to do to make the situation right and to make it so that all concerns are taken care of. She is a great person with a huge need to help animals; its who she is.

We ask that you let us make things right: for you, for us, and most of all, for the dogs. Let's remember that they are the innocent ones, and they deserve for us to fight for them. Compromise is the answer.



My name is Amanda Mills and I am writing as a volunteer for The Devoted Barn.

I started volunteering at the Devoted Barn in Dec of 2017. I have since volunteered every Saturday night in the dog room for the last 4+ years. I started volunteering after watching a live Facebook video about the dog program. I'm a nurturer by nature and have been around dogs my whole life. It sounded like something that would be great to get involved with. I had the time and they needed the help. I decided to bring my then 6-year-old son along with me, he loves dogs just as much as I. We started volunteering with the dogs on the weekend and quickly fell in love with them.

Through the years we have both learned so much about caring for dogs and dog behaviors. We've learned about caring for neonates and how to make enrichment for dogs. We learned about dog body language and how to leash train a dog that may be fearful of a leash. See, The Devoted Barn takes in abuse, neglect, and feral cases from all over the world and often cases from animal control. Learning all these things is helpful when caring for a dog that was abused before they came. They may be fearful of people, or feral. They may be fearful of life in a house having never heard a furnace come on or people knocking at the door. They may be neglected and never had a kind touch to let them know it's ok.

Working with these animals every weekend gives them a chance to see a kind person, know a kind touch, and hear kind voices. Each and every weekend I get to see a little more of each dog open up to us and enjoy feeling safe in their environment. They know when it's time to eat and when it is time to come out and play with their friends. We work every day with them on leash training. For the shy ones, taking treats means positive human interaction to get them on to their next journey in life. That's fostered in a home and then adopted into a loving family. That's our #1 goal. We want these dogs all to have a home one day.

In the past years since moving to Rose Township, we've seen so many improvements in the dogs and how much happier they are. We've also met a lot of new volunteers that are local to the rescue and have had some great new friendships built. The Devoted Barn put on some events at Halloween and Christmas time that invited the locals to come to see what we were about and it was a huge hit. There were so many people that showed up in support of animal rescue it was amazing. It made me feel happy to be part of something I always knew was an amazing place but for people to feel the same and want to volunteer and be part of it too.

As a current volunteer for The Devoted Barn, I am writing to offer support of the dog program. I volunteer up to twenty hours per week, sometimes 7 to 8 hours a shift, and the dogs at the barn have become an important part of my life. It has also become a place of solace and healing for me personally. After enduring a major health battle, I'd been suffering from anxiety. Since becoming involved with The Devoted Barn, my mental health and quality of life has improved immensely. The rescue is a place where I can go to decompress and solely focus on the care and well-being of the dogs. It's extremely fulfilling to see the progress of dogs that were once very fearful of humans; now accepting human touch. Let me assure you that every single dog at the barn receives the attention, love and care they deserve. I am proud to be involved in this program and contribute to their progress.

There is a misconception by some, that the dogs in the program are not being rehabilitated. You must first understand each one's history. Most of the dogs come from very traumatic situations and some are feral. A feral dog is very fearful and untrusting of humans. It takes time to earn their trust and to assure them that humans are okay. Charity is a great example of a fearful dog. She came to TDB from Genesee County Animal Control and hid in her kennel because she did not want to be seen. She was extremely shut-down and feral. Over time and with a lot of patience, compassion and training techniques, she has flourished. She is now a very happy girl that seeks attention, belly scratches and chin rubs. Charity enjoys running and playing with her buddies at the barn. She will soon be ready to go into a permanent home. I have attached a picture of Charity and another with her and King, who is now doing great in his foster-to-adopt home.

Strawberry is one of TDB criminal cases. Oakland County Animal Control works closely with Melissa Borden to house criminal/abuse cases. Due to the irreversible damage she sustained by her abuser, she is a permanent resident at TDB. Strawberry is a barn favorite and receives many visitors. She is very sweet and loves to snuggle with the volunteers. Despite her horrific past, she is a happy girl and brings so much joy to everyone that spends time with her. Some of my favorite

Melissa Borden has provided a safe haven for the dogs. On a daily basis, the volunteers devote hours of their time to ensure the dogs have fresh water, food, enrichment, clean kennels and adequate shelter to protect them from the elements. During cold weather, the dogs have igloos with straw to keep them warm. The dogs go out to play in groups. All of the dogs at the rescue receive veterinary care and medication when necessary. They depend on a regular routine, familiar surroundings and people they know that care for them. They receive this structure every day. To move them would be detrimental to their health and well-being. It would also disrupt the progress that so many of them have made.

As I'm writing this Rosie is laying right next to me. If it wasn't for what The Devoted Barn does, Rosie would have been euthanized! I would never have her or our bond. Rosie was 3 when I got her and she has many more years left with us. It's sad to know that she could have been euthanized had someone in California had not advocated for her.

The 3rd dog I adopted from The Devoted Barn is Lola. Lola has a cleft lip. Lola's breeder called when she and 3 siblings were born with cleft lips and palates. They can not survive without being tube fed every 2 hours. Melissa and a few other volunteers took shifts in taking care of Lola and her siblings day and night. Lola is now 7 months old and she is the funniest puppy. She is 40 pounds and thinks she has to sleep on our head.

If it wasn't for Melissa Borden and The Devoted Barn I wouldn't have my sweet dogs. My dogs are just as important to me as my children. The dogs that are currently at the Barn were in the same situation as my babies. If it wasn't for the program at the Barn they likely would have been euthanized not knowing love or human touch. The dogs are very loved by all the volunteers. We have watched these dogs go from being scared and shaking hiding in the back of a kennel to asking for pets and loving to run around, play with toys, and simply be a dog for the first time in their life.

Removing these dogs will take away everything that makes them feel safe. They will revert back into the scared fearful dog again. Some of these took years to feel safe and could be adopted in the future. Taking them from their safe home will take away all the progress they have made. We have dogs that came from the meat trade. They were tortured alive because in that country they think it makes the meat better. The Barn is the only thing the dogs know that has ever been nice to them. We have a few meat trade dogs that are now adopted and living in a home. The end goal is to have all dogs in a home. However, if they never get to that point, they are loved and well taken care of.

I ask everyone on the board that is making the decision whether or not to take the dogs safe home from them to come to visit the Barn. Come see how happy they are and how much time and energy every single day the volunteers put into these dogs. We have to be the voice for these dogs because there are so many people who just don't care what happens to them. This whole situation has really affected my 12-year-old daughter. She isn't old enough to understand what is going on. She just knows that the dogs she has grown to love over the years may not have a home anymore. The Barn has a lot of pre-teen and teenagers who volunteer. They are struggling with possibly not being able to see the dogs and work with them anymore.

There are so many people and animals who will be hurt if we are unable to build a new building for the dogs. I hope you find it in your heart to allow the dogs to stay on the property.





To the esteemed Rose Township Board Members:

I am writing on behalf of Melissa Borden and The Devoted Barn.

I have been following The Devoted Barn since January 2016, and have become close personal friends with Melissa and many of the volunteers over the last several years. Before Covid restricted travel, I would visit Melissa 2-3 times a year – taking whatever time I can away from my work here in California, because there are few other places I'd rather be. The barn has magic, calming quality that is hard to find in this day and age. The dog program drew me in and I've been amazed at the journey of many of these dogs - their rags to riches stories - overcoming the worst of humans - dogs beaten and left for dead, sexually abused, bait dogs, medical cases that need special handling, not to mention time and money. The Devoted Barn is home to all of these and more. I've been on rescue missions with herboth in Michigan and here in California. I've seen her gift with these dogs first-hand, up close and personal. It's like watching a uniquely choreographed ballet - and watching these dogs stop and give her a sign they might trust her - when no one else has been able to make a difference. What a gift, what an amazing, heartwarming gift. You have this gift right in your community and while the outside package may be brown paper, the inside is a priceless jewel.

I've co-written books on some of the barn animals in an effort to educate and spread her mission - "Teaching compassion through positive action." Let's get back to compassion and positive action on all fronts. Not hate and unfounded accusations.

When I look at everything going on in the world today, pandemics, hate, divisiveness, politics (regardless of party), hurricanes, earthquakes, wars, pending wars, homelessness, drug abuse and so many other tragedies befalling on the world, it's refreshing to see a small oasis in the town in Michigan that offers solace to both animals and humans alike. I've seen these animals come through the doors and do a complete 180 in temperament and behavior. Shut down animals who have never allowed human touch now cannot wait for human interaction. Dogs, once so fearful, now can be hand-fed and are learning to trust and how to interact with other dogs and learn how to be, just that, a dog. This is a beacon of light that lives in your township. One I would assume the township would be proud of and boast about. I respect all of you for wanting to be of service to your community, which is exactly what Melissa's goal is as well. I cannot fathom why you are all not working together, but fighting to the extent of spending 10's of 1000's of dollars that could be better spent in a myriad of more productive ways. Melissa is not perfect – and she has never claimed to be – but if any of you can claim that you have reached the peak of perfection in this lifetime, please stand up. I'll wait. And I'll be the first to pat you on the back and congratulate you for that achievement. Still waiting.....

Social media is a huge part of today's society. There are positives and negatives to this. The Devoted Barn has over 110,000 followers on its Facebook page. Somehow I don't believe that many people are there because they're haters or vengeful. People from all over the world follow the barn's activities daily. We get to know the animals up close and personal. We know their backstories. We celebrate the successes and mourn the losses – just as if they were our own pets. On any given day, Melissa will do live videos highlighting a part of the day at the barn to give her followers a closer glimpse of barn life. People live for these videos – I know I have often stopped what I'm doing at the drop of a hat, to view and participate. She's created a family of animals and humans, locally and internationally – which is a huge victory in today's chaotic world. There are no prejudices against breed, species, gender, among the animals OR the volunteers that dedicate their free time for the betterment of these animals. No one expects anything back – other than to see the animals thrive and blossom. Many of these animals have come from neglect and abuse situations and would otherwise be dead if Melissa had not stepped in. She's called upon by law enforcement, court judges, animal control, and other national and international rescue organizations, not only for her expertise but her compassion and ability to communicate silently with these animals. The trust they have in her is unlike anything I've ever seen. She has a gift – and one that serves the purpose of the greater good in this world, the state of Michigan, and most directly the township.

Melissa is the point of contact for animal cruelty cases for Oakland County. I have no doubt that they have done their vetting of Melissa and the property or they wouldn't have forged this relationship. That being established, it's no secret that AC officers must come out to the property often to examine and check on the animals in holding. If there were significant issues as what is being reported, do you really think they would continue to nurture this relationship? UDAG has been out to the property on numerous occasions based on frivolous complaints. Again, do you think they would turn and look the other way if all these accusations were valid? If so, there's a hell of a lot more corruption going on than anyone realizes. Because there's not. And you, as mature adults, know this.

Melissa is a rule follower, whether you believe this or not. Her weakness is that she is too trusting. She trusted the seller when she purchased the Holly property, only to find all the hidden issues after the sale had closed. She is fighting daily to make much-needed improvements to the property that was sorely neglected upon purchase, not to mention all the infractions that went unnoticed prior to the sale. Melissa did her due diligence with the township before she bought the property and believed she was following the rules, only to have a disgruntled person provision to change the rules on a whim and then penalizing her, even though she had the proof to answer to the allegations, but no one will listen or review the facts. How many times has she invited you all out to the barn – to drop in without notice – an open invitation – and yet no one has accepted that. What does that say about you and your scruples? You're so hell-bent on listening to some people who feel slighted and have time to speculate and draft up elaborate misguided stories without context or understanding. Why is there so much hate and why do you support that hate as much as it seems you do.

Melissa works with worldwide organizations and rescues across the country who turn to her for her expertise on feral and fearful dogs. She would not have this support if she were the horrible person she is being painted out to be. She has a gift and because of all this frivolous fodder, so many dogs are being left to suffer at the hands of the uneducated or shelters & rescues that are so overwhelmed with so many dogs. You can't tell me that you think it's okay for people to keep their dogs chained to a tree or dog house in the freezing and frigid temperatures — yet your target is Melissa and her dog program. I have been there, I have seen these dogs and the amazing volunteers first hand. These dogs are in the best possible circumstances they can be as they evolve into social dogs and eventually go to foster and then adoption. Yes, some dogs will never make that transition — and that's okay. Some people can't make a transition to be social or function, yet the social services system in this country is less than stellar. Let's turn some attention and focus on the situations that truly need people's attention.

The volunteers that work with these animals, especially the dogs are second to none. They spend hours upon hours working with these dogs. Some of them drive hours several times a week on behalf of these dogs. Do you think this is because they have absolutely nothing to do? They have families, jobs, yet this is their happy place – this is their reward in this life to be of service and to give back to animals who have been failed by humans at one point in their lives. Why are they being punished for being compassionate, empathetic, caring? And believe me, there is no "Kool-Aid" being served. The hypocrisy of this world is that people demand more of this – humanity, compassion, empathy – yet then target the very thing they claim they want because of whatever the reason.

Animals are not being abused or neglected and you know this. And you can confirm this in a heartbeat if you would accept the invitation to take a tour. What are you afraid of? Hell, I'll pay for your dry cleaning if you're afraid of getting your clothes dirty. The fact that you won't go see firsthand what you're fighting is incredulous. Again, what are you afraid of? That you'll agree with what so many supporters, government agencies, rescues, shelters, vets, have been reiterating for years. The Devoted Barn is a solid, stellar, integral part of the rescue world and you should be honored to have such an establishment in your community. Let's do a paradigm shift here please. Open your minds, leave the judgment at home and come tour the property. Meet the dogs, learn their stories. Support Melissa's plans to build a new dog room in the interior of the property. She's trying to do right by the township, by her volunteers, by her family, and by you – the township, who just seem to have an unfounded vendetta and are willing to spend thousands of dollars for no real good to anyone. Stubbornness has its place at times, this is not that time. Those stubborn donkeys actually are protectors – let's learn from them and protect The Devoted Barn.

The Devoted Barn is a beacon of light and hope in times of a world that's unstable whether by man's hand or nature. She deserves to be praised for her sacrifices, commitment, her dedication, and hard work to make the world a better place where and when she can. Isn't this what we all want at the end of the day? What <u>we</u> strive for? There's too much negativity in life, and we have the power – <u>you</u> have the power to take a stand against the hatred and strife that so many deal with day in and day out. I believe in your hearts, you know what is right, and that good and kindness will prevail. Let's all be part of the solution and not so much the problem. I beseech you to do the right thing.

My name is Michelle Foster, and I have been a volunteer at The Devoted Barn for the past 5 years. I have spent countless hours working with the dogs and the horses, doing new volunteer orientations, fostering dogs, helping with and planning fundraising events, and doing other miscellaneous activities around both the Newport and Rose Township properties. I have put so much of myself, my time, and my money into this program over the past 5 years, and I would like to tell you a little bit about why.

The barn has been a haven not only for animals, but also for people for a long time. It is a place that volunteers can go and feel like they have made even a small contribution to the lives of the animals when nothing else in their world is working. It is a sanctuary in so many ways.

The dog program is what first pulled me in to volunteering with the barn. I would come home from my job and just watch the live videos of Melissa working with these fearful and feral dogs and teaching them that humans aren't so scary. Most of these dogs would have been euthanized in a regular shelter or animal control setting, as they were not ready for typical homes. At the barn though, they found a safe place to build relationships with people, where the dog dictates the timeline. It was incredible to watch and has been just as incredible to experience in person. Having a dog who was absolutely terrified of people start to wag his tail because he recognizes you as one of "his people" is an amazing feeling. Watching that dog start to trust you enough to pet him for the first time just fills your heart and lets you know that things in this crazy world might just be ok in the end.

Just today, I took my feral foster dog to her adoptive home. When she first came into my care, it took 3 months before she would let me even touch her. Last night and this morning, she was laying across my lap asking for belly rubs. Yes, it took a lot of time and effort and treats and reading her body language to determine when she was ready for more, but it was worth it as she is one of the many, many success stories to come out of The

Devoted Barn's dog program. While she was never a resident inside the barn dog room, the training I learned working with the dogs there allowed me the confidence and skills to bring Heidi home, and work with her until she was ready for her own adoptive home.

The Devoted Barn's volunteers are a group fully dedicated to the lives of these animals. All animals on the property are well fed, provided with clean water regularly, and given comfortable and clean places to live. Most importantly, the volunteers ensure the animals are incredibly well-loved, for however long we have them in our care. If you have not been out to visit the sanctuary, I invite you to please come and see the work being done. I give tours and teach new volunteer orientations regularly and will happily take you around the property myself.

I implore you to please allow us to continue the work being done with our dog program. As I stated, for most of these dogs, this is their chance to be loved and to learn to trust and love humans back. For the humans, it is a chance to make a difference in the lives of another creature, find some solace when needed and have some quality companionship at any time. It is a chance to add some kindness into a world so desperately in need of more of it.

The past 8 months I have spent 12-14 hours a week tending to the care of the horses, livestock along with heading up projects like quotes on new fencing for the farm along with installation of new hydrants for water through out the farm. The barn family has welcomed me with open arms, no matter my abilities nor my commitment.

I love doing farm chores here, the animals always are fed a top quality feed along with their normal added diet additions like medication, pain management, prescriptions and so forth. Everyday is an adventure and a day to clear you mind because if you think of the situation's that most of these animals came from was horrifying to say the least they now can rest, never to wonder where their next meal will come from or what abuse they will have to endure. To watch these animal trust again, run and play, is the most rewarding part to witness. They get endless attention and love along with the normal exercise that is required to live a long happy life.

I have been present many of times as the barn veterinarians are out doing their normal assessments on the animals, changing medication, re assessing the progress that some of the animals require. Once a month the dog veterinarian who also attends to the cats and other special needs animals comes out and spends the day up dating, spay and neuter's, re assessing the special needs dogs where the foster family's bring their dogs and cats to the barn to receive much needed veterinary care. All of the adoptable dogs and cats are in foster care off site, the only dogs that remain in the care of volunteers are those in the feral dog program whom are housed at the barn.

Melissa's feral dog program is nothing like anyone else, and is the only one in the USA that has received numerous awards for her teaching, rescuing and publics awareness. This program has been put on hold ever since the lawsuits were presented, and I find it a shame that the teaching of empathy and compassion had to stop, when the torture, abuse and homelessness continues.

Every day I take in numerous packages from UPS, FED X, USPS and Donations that are brought to the barn by our school system and residences alike in support of The Devoted Barn. Truly an eye opening experience.

While barn chores are not everyone forte there is much more to The Devoted Barn family, I have never met such compassionate, knowledgeable, hard working individuals in such a volume. Everyone has a something to give and the animals at the barn all benefit from all of it. While under the devoted barns care, we do have criminal cases that come in regularly and the animal control officers always are so impressed with the accommodation's, the barn has to offer. I have been there for a couple of these visits, because if we were not able to provide what is required for each and every animal on the property they certainly would not contract to the barn to take in these animals under their control. Criminal cases as I have learned is a rather lengthy process, and I have been told that they cannot believe how great the animals they had dropped of look like now.

The devoted barn has so much to offer our community if it was able to do so. The Halloween and Christmas open house were enjoyed by not only the residences but we had family's from all over Michigan stop in and enjoy themselves. Ending this letter, I will have to tell you all that those feral dogs deserve a chance to work through the program and not end their lives because of several peoples bias feelings.
